NEW ASSOCIATION PRESIDENT REPORTS ON CHAPTER

Dear Brothers,

As the new president of the Gamma Chapter House Association, I would like to take a moment to bring you up to date on some of the transformations that have occurred over

the past year. For a number of years, a group of alumni who attended Cornell during the 1950s has been meeting socially on a semi-regular basis, and during their meetings, the condition of the aging chapter house has been a topic of conversation. From these gatherings, several of the alumni formed a team that desired to become more actively involved in supporting the refurbishment of the chapter house. The names

of Bob Chase '59, Walt Whitman '58, Bob George '57, Steve Hall '56, Bob Hoffman '58, and Ron Obermeyer '60 come to mind. I am sure there are others who are involved as well. At some point, Steve Hall took the lead in organizing this effort and contacted Steve Fontana, the president of the Gamma Chapter House Association at the time. Steve F. was naturally quite excited to hear of the interest of other alumni in getting behind the chapter house association.

Discussions progressed, but it was clear that the association really didn't have a formal structure that easily permitted multiple voices in the management of the chapter house. There was no board of directors. Steve Fontana and his predecessors had been left to shoulder the whole burden of running the association for years. In fact, according to Bob Chase, a long-time president prior to Steve Fontana, no formal structure has existed for decades. A search of the corporate records also indicated that the bylaws of the organization had somehow been lost.

To correct this situation, Steve Hall offered to draft a set of bylaws. When that was accomplished, Nick D'Ambrosia '77, who has been a great help to the association for years when legal advice was required, stepped in and reviewed the draft document. At that point, the association had a basic organizational blueprint.

Over the summer, it became clear to Steve Fontana that the proposed new structure might give him a chance to step back a bit from having to direct all the traffic for the association. He sent out a letter to all alumni requesting that someone contact him about serving as presi-

dent. I responded to Steve's letter and, after several discussions, agreed to volunteer if he agreed to stay active in the alumni association;

and of course, if the brotherhood would accept me in that role, and the new board felt I was the proper person to work with going forward.

On October 15, the Gamma Chapter House Association held its annual meeting. At the meeting, seven new board members were elected, and I was confirmed as president of the association. Since then, the board has met on three occasions: once to elect other association officers; a second time to discuss how we go about developing capital planning strategies; a third time to make some further revisions to the bylaws. The board members have been very giving of their time and provide a wide array of experience that will be valuable to the association in the future.

Let me take a moment to highlight the experience of the seven board members who currently represent your interests in the Gamma Chapter House Association.

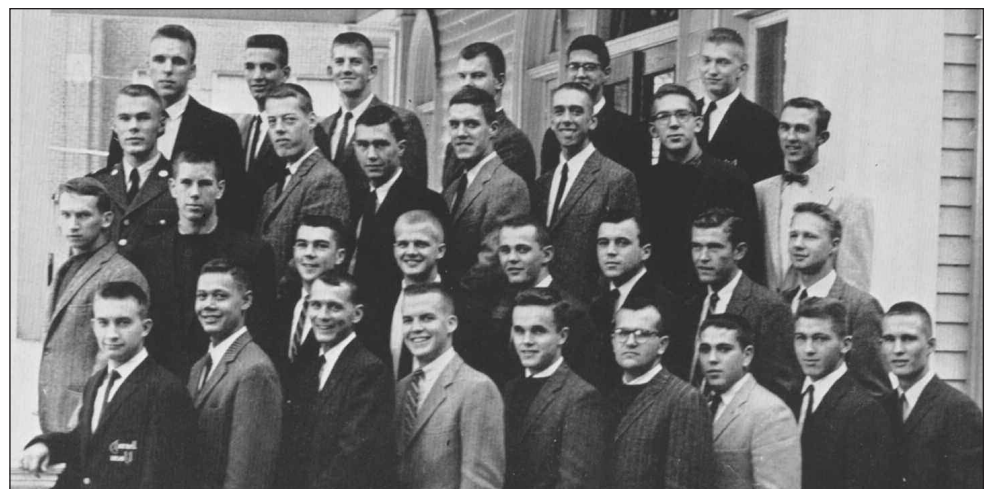
Many of you surely know Robert "Captain Nemo" Chase. Bob joined the faculty of the

A LOOK AT EXPENSES FOR THE PAST FIVE YEARS

Dear Brothers,

Since becoming president of the Gamma Chapter House Association in October 2009, I have had a chance to speak with a number of brothers representing various segments of our alumni and several current undergraduate members. From these discussions, I realized that there seems to be some misunderstanding regarding what happens to alumni contributions and why undergraduate rents continue to increase, even though most of the association's costs seem to be more fixed than variable. I would like to take a moment to address these concerns so that everyone feels comfortable about how financial responsibilities are shared by the members of the association.

First of all, several members of the alumni expressed their dismay that their contributions are going to subsidize the current operating costs for undergraduate members. I do not know how they arrived at this assessment, but the fact is that alumni contributions are used solely to cover operating costs of the Gamma Chapter House Association, to produce *The Gamma Contact*, and to provide some assistance in performing needed capital improvements to maintain the chapter house as a suitable residence for our undergraduate brothers.

I would like to give you a general summary of the past five years. Let me begin with the

contributions made by our undergraduate brothers. During the past five years, they paid the Chapter House Association \$339,000 in rent. These rental payments covered \$130,000 of taxes, \$44,500 for insurance, and \$94,000 for maintenance costs that were non-depreciable repairs to the physical plant of the house. This left \$70,500 to contribute to the capitalized repairs and improvements of the chapter house. The daily operating costs managed by the undergraduate chapter members, by the way, are handled completely separately from the association and are in no way mingled with the activities of the Chapter House Association.

Over the same five-year period, alumni dues payments totaled \$121,000. The cost of producing the *Gamma Contact*, maintaining current association mailing lists and soliciting alumni contributions totaled \$63,000. In addition, there were various association expenses for accounting and general administration that totaled \$8,000. As a result, the Gamma Chapter Association alumni contributions provided \$50,000 for potential capitalized repairs and improvements. That being said, I think the seven to five ratio of capital contributions between undergraduates and alumni seems about right, considering the actual expenditures that have been made. From 2004 through 2009, actual depreciable capital

expenditures totaled \$99,000. Plus, there have been several major capital expenditures to replace the heating boiler and the water heater that have cost an additional \$12,000 just this year. Including the recent expenditures with the \$99,000 of capital expenditures over the past five years, the Chapter House Association garnered \$121,500 in net revenues to cover capital costs and disbursed \$111,000.

In conclusion, the undergraduates' rent is priced correctly to cover all the operating costs of the chapter and to provide a reasonable return to contribute to the ongoing capital needs of the chapter. Alumni dues provide the cushion needed to keep the chapter house in solid physical condition but are not being used to subsidize current membership operations. As we look to the future, I would hope that all of us—whether it is the most recent inductee or more seasoned alumnus—will recognize the value of continuing their affiliation with the Gamma Chapter of Phi Sigma Kappa. We have a new board with a lot of interest in trying to improve communications and our abilities to serve all the alumni of the Gamma Chapter of Phi Sigma Kappa.

School of Hotel Administration at Cornell in 1962 teaching property management, information systems, accounting, finance, and business strategy. In the mid-1960s, Bob began developing the first of several "management games" that have been used extensively as training tools throughout the hospitality industry. Bob has also done numerous executive development programs for companies including AT&T, IBM, ITT, Prudential Insurance, NCR, and American Express. He served as association president and chapter adviser for many years through the 1960s and '70s.

Steve Fontana '79 moved back to Ithaca in 1981 to buy the family business, Fontana's Shoes. He currently owns and manages several residential housing properties throughout the greater Ithaca area. He first became the GCA president in 1981 and served in that role through the late 1980s and had a key role in the successful Gamma Centennial Campaign to raise money and rebuild the chapter house infrastructure. While taking some breaks from the president's office in the 1990s and during a part of the last decade, Steve has always stepped up and provided the association with leadership when it was needed.

Steve Hall '56 grew up in Waverly, New York, just 34 miles from Cornell. He followed two of his older brothers as a member of Gamma Chapter of Phi Sigma Kappa. At Cornell, he met his wife of 54 years, Marge, and graduated in 1956 as a Marine Corps officer. During his career, Steve earned his MBA from Michigan State and an M/Div degree from Harvard. His varied work experience includes 13 years with ITT-Sheraton and five years as vice president of administration at Harvard University. He has also served as dean of students at Glion in Switzerland and as associate pastor of the American Church in Paris. Steve has published three books on quality and ethics in hospitality.

Bill Miller '73 spent 31 years in the securities industry. He became a New York Stock Exchange-licensed branch manager at the age of 29. At 33, Bill became head of compliance and operations for the mortgage-backed securities department of Butcher Singer. Two years later, he became first vice president and deputy division manager of the broker dealer

services division of The Exchange National Bank. Next, he moved to LaSalle National Bank. In his nine years with LaSalle, Bill served for a time as the division head for risk management and later as head of sales and trading. Finally, Bill spent nine years with Ryan Beck & Co. where he headed the firm's fixed income products group.

Ron "Obie" Obermeyer received his BS in mechanical engineering in 1961 and MME in advanced propulsion in 1962. He was commissioned as a second lieutenant in the U.S. Air Force upon graduation, had a distinguished military career from 1962 to 1987, retiring with the rank of colonel, followed by a successful private sector career. Highlights include an assignment as an associate professor of engineering at the U.S. Air Force Academy and working on several major international cooperative NATO programs with the Office of the Secretary of Defense and at senior corporate levels. Ron currently serves as president of the Potsdam Foundation, a non-profit corporation to promote transatlantic education and understanding between the U.S. and Germany.

Michael Weiss '06 is our youngest director and has great insights into the needs of current undergraduates. While at Cornell, he was actively involved in the Greek system and served as executive vice president of the Order of Omega Greek honor society as well as the chairman of the university's social policy committee, which reviewed the policy in place and drafted a new policy for the approval of the IFC, which is still used today. Most recently, Mike graduated from the American University Washington College of Law where he was on the administrative law review and was the president of the sports and entertainment law society. He now lives in Manhattan and will be working in the real estate department of Mayer Brown LLP beginning in October 2010.

Henry Ver Valen graduated from the five-year engineering program at Cornell in 1953. After three years in the Navy, He joined Bendix Corp. in Baltimore, Maryland. While progressing through the engineering ranks at Bendix, Henry obtained a second engineering degree from Johns Hopkins University. After rising to the position of plant engineer, Henry left Bendix to join Dravo Corp. in Pittsburgh, Pennsylvania, where he worked until his retirement

in 1990. At the present time, Henry is back in Baltimore and continues his 56-year interest in restoring and driving older Jaguar sports cars.

As you can see, the board of directors has a wide variety of experience that provides extremely useful insights for guiding our association. While not everything will fall into place immediately, we are all trying our best to craft a strategy that will best serve the Gamma Chapter House Association in the future. As we move forward, we would welcome your suggestions, advice, and active involvement. Over time, we feel that there is much more that we can do to make a lifetime commitment to our fraternal organization a highly beneficial experience for all brothers. To accomplish these objectives, we will need help from a number of you who have the skill set and experience to guide some of these projects. While it may involve a commitment of some time, it is a good bet that the brothers who participate in creating these alumni-oriented services with probably see the most value provided by those same services and leverage them to the best of their ability.

What Steve Hall and his group of fellow alumni from the '50s have proved clearly is that we have a great group of concerned alumni willing to get involved, should the need arise. In the short time I have served as president, I have also gotten commitments from brothers from the '40s, the '60s, the '70s, the '80s, the '90s, and the '00s to step up, should they be needed.
